

ARTICLE IV. - PEDDLERS, HAWKERS AND ITINERANT MERCHANTS

Sec. 10-94. - License required.

No person shall engage in or conduct a business of any kind as a peddler, hawker, itinerant merchant or transient vender of merchandise without first procuring a license under this article.

Sec. 10-95. - Application; bond.

- (a) Application shall be made in writing to the city council at least three days prior to the time that the applicant desires to commence in such business. Such application shall state:
 - (1) The name and residence of the applicant;
 - (2) The nature of the business;
 - (3) The kind of goods to be sold and where the sales are to be made;
 - (4) The length of time for which manufactured or produced, and the firm or corporation and its address, represented by the applicant.
- (b) Such application shall be accompanied by some evidence, oral or written, that the applicant is of good reputation and character.
- (c) Such application shall also be accompanied by a bond in the penal sum of \$1,500.00 to the city, the bond to be executed by good and sufficient sureties to be approved by the mayor and conditioned that all goods, wares and merchandise will be as represented, and that the purchase price will be refunded on any article sold which is not as represented, and that final delivery of goods ordered will be made in accordance with the terms of the order, and failing therein, the advance payment on such order will be refunded.
- (d) Any person aggrieved by the action of any such peddler or itinerant merchant shall have the right of action on the bond for the money paid or damages, or both. Such application shall also be accompanied by a license fee for the period for which the license is sought.

Sec. 10-96. - License fees.

The license fee for a peddler's license, hawker's license, itinerant merchant's license or transient vendor's license shall be as provided in the city fee schedule.

Sec. 10-97. - Applicability of license requirements.

The provisions of this article shall not apply to commercial agents selling to merchants in the usual course of business, nor to persons selling vegetables or other products of their farms or gardens, nor to children under 15 years of age, nor to persons who have regular and permanent places of business in the city for the sale of meats, fruits, vegetables, baker's goods or dairy products, and in connection therewith may desire to peddle the same class of goods within the city.

Sec. 10-98. - Violation; penalty.

Any person violating any provision of this article shall be fined not less than \$100.00 nor more than \$500.00 for each offense; and a separate offense shall be deemed committed on each day on which a violation occurs or continues.
